## OVERVIEW

**Unavailability of Individual Items and Subsequent Vintage Replacement:** If the individual items originally ordered are not available or able to be replaced by subsequent vintages when fulfilling your order, we will promptly reach out to you for confirmation regarding your satisfaction with the proposed alternative products.

We reserve the right at any time to modify or discontinue the Service (or any part or content thereof) without notice at any time.

- Sparkling wines and champagnes, prone to gas buildup, demand extra caution during the opening process.
